HOW IT WORKS

Your paycard is loaded once your pay is calculated. There is no need to wait for bank transfers or check cashing.

By working for PeopleWorks, you automatically qualify for a paycard. No credit check or bank account is required.

1. Fill out a Payment Election form.
 2. Activate your paycard by either calling 866.929.8096, or going online at www.globalcashcard.com/activate.
 3. Enter your card number and the last four digits of your Social Security number, and select a four-digit PIN. This PIN and the Visa Zero Liability Policy* protect your money. All card balances are guaranteed by the FDIC.
- When you're activating your card, also set up text message or email alerts at www.globalcashcard.com to be notified when your paycard is loaded on payday. You can also text to receive your paycard balance, activity, and payroll.***
 - Visit www.globalcashcard.com, or call GCC to check your paycard activity.

Below are several ways to use your card, and avoid surcharges:

- Shop online and anywhere Visa is accepted.
- Use it as a credit or debit card.
- Get cash at any  Network ATM.
- Pay bills online, or make purchases directly with merchants.
- Use the online bill pay system at www.globalcashcard.com.
- Get up to five additional cards for family members. Transfers are available at no fee, and your family members can use only the funds you put on their cards.
- DO NOT pay at the pump when buying gas. Pay inside to avoid lengthy holds of funds.
- Access your paystub at <https://cardholder.globalcashcard.com>. Select paystubs from the top menu.
- Request a personalized Visa paycard from GCC at any time.
- Other card features may require transaction fees, costs, terms, and conditions. See the Cardholder Agreement for more details.
